THE ESSENTIAL CONSULTANCY SKILLS COURSE AND THE CMI CONSULTING QUALIFICATIONS

The ECS is a CMI recognised professional course which leads to the CMI's Award or Certificate in Professional Consulting at level 5 on the UK Government's OFQUAL recognised Qualification Credit Framework (QCF).

The course is at degree level and provides foundation level skills in management consultancy. It is intensive and highly participative. It covers theory and practice with extensive syndicate working. Case studies and role playing are included. Daily review sessions are held to reinforce learning. A comprehensive course manual together with handbooks for the CMI Modules are provided. There is a high level of mentoring is provided during and after the course.

Options - Delegates can:

- Attend the ECS alone and be given CMI certification of attendance at a recognised CMI course; or
- Undertake further post course work for the CMI's Award or Certificate in Professional Consulting (see below)

THE CMI'S AWARD AND CERTIFICATE IN PROFESSIONAL CONSULTING

Delegates wishing to proceed to the Award or Certificate have to complete the ECS course then undertake post course project work. This involves competing one module for the Award; and two modules for the Certificate. These modules take about 50 hours work each.

Full guidance is provided for each module in Student's Handbooks these include links to the CMI data base. Extensive mentoring support is given both during the course and after. Delegates are invited to send draft answers to the Course Director for mentoring, normally by email or face to face.

The completed answers are sent to the CMI for evaluation.

The Chartered Management Institute (CMI) - see www.managers.org.uk - is recognised by Royal Charter as the leading body for management in the UK. It has over 200000 learners working towards its various management and consultancy qualifications through over 300 centres in the UK and abroad. The CMI is the awarding body for the Award and Certificate in professional consulting, and these are monitored by the UK Government's Office for Qualifications OFQUAL.

The Institute of Consulting (IC) - see www.icon consulting.org.uk - is part of the CMI and is professional UK body for consultants and maintains the professional standards and competences for the profession. It has a code of conduct and required ongoing Continuous Professional Development (CPD). The IC is one of over 50 consultancy institutes world wide that belong to the International Council of Management

Consultancy Institutes (ICMCI) - see www.icmci.org - which sets out global standards and provides the international Certified Management Consultant (CMC) qualification. The IC awards the CMC on behalf of the ICMCI.

The CMC qualification is a competency-based qualification for consultants with about 4 years experience. It is conducted by the CMI/IC. For full details see www.icon consulting.org.uk. CDI provides a mentoring workshop for this qualification. CDI is an authorised to provide assistance for CMC candidates and is an authorised CMI mentor.
